Composition

Metolachlor 290 g/L + Atrazine 370 g/L

Prime Gold™ 660SE combines two active ingredients with different mode of action.

- Metholachlor is chloroacetanilide herbicide acting by interfering with the weed's fatty acid synthesis. HRAC/WSSA Group 15 (K3)
- Atrazine is a triazine herbicide, acting by inhibiting the photosynthesis at photosystem II. HRAC/WSSA Group 5 (C1)

Directions for use:



Prime Gold™ 660SE should be mixed with water to be ready for application and can be used with manual knapsack sprayers or tractor mounted boom sprayers. Ensure full cover of weed canopy for maximal efficacy. Application volume should be 200-400 L/Ha

Crop	Application Timing	Application Rate
Maize	Pre-emergence or Pre-plant incorporation	2.5 - 3.0 lt/ha
Cassava, Sugarcane	Pre-emergence	

Application notes:

1. **Prime Gold™ 660SE** is activated by rain/irrigation.
2. Pre-plant incorporated (ppi): Apply **Prime Gold™ 660SE** to the soil and incorporate into the top 5 cm of soil within 14 days before planting, using a finishing disk, harrow, rolling cultivator or similar implement. Use pre-plant incorporated application when a period of dry weather after application is expected.
3. Pre emergence: Apply durin or after planting but before weeds and crop emerge.
4. Early post-emergence: When grasses are beyond 2-leaf stage, as a less reliable emergency treatment.
