Active Ingredients

Profenofos 40% + Cypermethrin 4% Emulsifiable Concentrate

Cypermethrin

 Pyrethroid insecticide, IRAC Group 3A

A synthetic pyrethroid insecticide with fast action and knock down effect. It has both contact and stomach action activity.

Profenofos

 Organophosphate insecticide, IRAC Group 1B

An Organophosphate insecticide with ovicidal and acaricidal activity. It has both contact and stomach action with additional translaminar properties.

- Long lasting effect which is sped up by high temperateures and high relative humidity
- Does not affect the flavour and odour of the treated crops
- Effective against a wide range of differentiating insects (aphids, thrips, caterpillars, beetles, etc)
- Quick knock-down effect
- Synergistic power with both contact and stomach nsecticide action
- Combination of insecticides with two different mode of actions
- Translaminar activity, leads to increased efficiency against insects in "hidden" spots and the lower surface of the leaves



Application Rate

Crop	Pest	Application Rate	Notes
Cereal (Maize, Wheat)	Lepidoptera pests, Aphids, Thrips	400 – 600 ml/ha ; 50 – 80 ml/100 l water	Apply upon pest appearance. Ensure thorough coverage of the pest canopy.
Cotton	Lepidoptera pests incl. Bollworms, Aphids, Spidermites, Thrips		
Soybeans, Beans, Peas, Groundnuts	Aphids, Lepidoptera pests, Thrips, Whiteflies		
Vegetables (Potatoes, Tomatoes, Peppers, Onions)	Aphids, Lepidoptera pests, Thrips, Whiteflies, Spidermites		

- In order to delay insecticide resistance, always alternate with products with different mode of action.
- Mix the required quantity of Golden Pro[™] 200EC with water in a spray tank while stirring or with agitator in motion
- Apply when the insect infestation reaches economic threshold level
- Repeat application at 10 15 days interval if infestation persists.
